# BOARD OF TRUSTEES HARRISON COUNTY PUBLIC LIBRARY MINUTES REGULAR MEETING February 23, 2023

A regular meeting of the Board of Trustees of Harrison County Public Library was held on February 23, 2023. The meeting took place at the Corydon branch of Harrison County Public Library, 105 N. Capitol Avenue, Corydon, IN. Members of the Board of Trustees present: Kathy Crimans, President; Sharon Mathes, Vice President (joined by Zoom at 3:00 p.m.); Barbara Smith, Secretary; Jon Howerton, Suetta Tingler; Alisa Burch, Director; Jessica Stroud, Head of It; and Diana Lasky, Administrative Assistant/Recording Secretary. Derrick Grigsby, Treasurer and Roger Windell were absent.

Kathy Crimans called the regular meeting to order at 3:04 p.m. A quorum was present.

Eden Ransdell and Alisa will accompany Pete the Cat (Diana Lasky) to Heth Washington Elementary School on Monday, February 27. HWES won the visit by being the top reading school in the 2023 Winter Read Challenge. The entourage will visit each preschool through third grade classroom.

Sonitrol will do their annual fire test February 27 at Main and Genealogy at 7 a.m., February 28 at Palmyra at 7 a.m. and March 1 at 7 a.m. at Lanesville. As part of the test Sonitrol will test horns, hold canned smoke to each detector to test functionality, and test all pull stations.

The Indiana State Board of Accounts Annual Financial Report has been submitted and the Cash & Investments Combined Statement – 2022 will appear in the March 1, 2023, Corydon Democrat. A copy of the statement was given to board members.

Barbara Smith made a motion to approve the HCCF Endowment Requests from the Nancy A. Keller Genealogy Library Fund in the amount of \$1,486.10 to enlarge digital storage space for HCPL's digital archives and from the Frederick Porter Griffin Fund in the amount of \$3.535.11 for CONTENTdm base subscription software to build and showcase the HCPL digital collections on a personalized website. The library board affirmed by email and voice that Alisa can proceed with forming a Lanesville branch committee to determine the next steps for the branch. Committee members will include Alisa Burch, Jessica Stroud, Trevor Smith, Nancy Rosenbaum, Kathy Crimans and Barbara Smith. The board recommended that input be sought from maker space enthusiasts and experts from the community.
