The AFR (Annual Financial Report to the Indiana State Board of Accounts) was submitted through Gateway on February 11. An output of that report, the Cash & Investments Combined Statement 2024 was printed as a legal notice in the February 19th edition of the Corydon Democrat as required by Indiana Code.

This year units were also required to submit the Gateway Debt Management Affirmation and Contract Upload Affirmation to be eligible for the DLGF to approve a 2026 budget. Alisa completed those affirmations on February 13.

Alisa provided an update on the 2025 Read to Feed Harrison County Winter Reading Program, sharing that a total of 15,255 books were logged. The goal was 10,000 books. NMES was the highest-performing school, recording the most books read. Pete the Cat visited NMES and performed for the students with Eden Ransdell.

Alisa distributed the updated board contact sheet for 2025.

Alisa submitted the Indiana State Library Annual Report on February 26. Kathy Crimans' signed the report at this regular meeting.

Assistant Director Jessica Stroud created a <u>donation page</u> for the HCPL website and "Ways to Donate" cards for distribution to the public.

It is time for HCPL to attend a Commissioners and Council Meeting. Alisa and Kathy Crimans will schedule to appear on their respective meeting agendas.

Alisa provided the ILF President's Statement on Senate Bill 1: Property Tax Reform.
